SUMMARY OF RESPONSIBILITIES

- f) Write, analyse, review and re-write programmes, using workflow chart and diagram and applying knowledge of computer capabilities, subject matter and symbolic logic.
- g) Develop and maintain documentation in an effort to provide clear understanding of the purpose and operational procedures of the programme
- h) Maintain a catalogue of all software programs and reports
- i) Maintain historical records by documenting programme development and revisions
- j) Confirms programme operation by conducting tests, modifying programme sequence and / or codes.

- I) Prepare reference for users by writing operating instructions
- m) Troubleshoot system and application problems
